With positive educational momentum and a supportive community base, the Osceola County School District in the heart of Central Florida is searching for a Superintendent to take the district on the next leg of its journey to greatness. The district is a formidable economic engine in the Central Florida area. Osceola's future economic growth and increased prosperity are assured with the new Medical City on its northern border, Walt Disney World and other attractions to the west, a new Valencia College campus to be built in Poinciana to the south, and the Florida Advanced Manufacturing Center, a new high-tech manufacturing facility, in the heart of the county. This K-12 school district, which is comprised of 52 schools with an enrollment of approximately 60,000 students who are supported by 7,000 employees, was one of only five school districts in Florida to improve on all seven academic areas according to the 2014 Florida Comprehensive Assessment Test. With a total annual budget of approximately \$838 million dollars, the district's Science, Technology, Engineering and Math (STEM) programs are expanding, and the district is piloting the state's first mobile STEM Lab. Osceola's English for Speakers of Other Languages (ESOL) Programs are recognized throughout the state for their effectiveness and support of the county's diverse student population. The five-member School Board of Osceola County seeks a Superintendent with a Master's degree or equivalent from an accredited institution, and a minimum of 10 years of executive administrative and/or management experience. The successful candidate must be eager to lead a high-achieving district; be familiar with the latest research on educational leadership, student achievement and school effectiveness; and have the vision, energy, and financial background to manage a complex organization.

The position start date is projected to be no later than June 1, 2016. The Board is prepared to offer a three-year contract with a salary range of \$185,000 - \$225,000, plus a competitive benefits package. Candidates selected as finalists must be available for interviews during the week of January 11, 2016.
