III. Financial Reports

A. FY 2017-2018 1st Quarter Financial Statements

- 50 Districts have paid their dues and we are below last year's number at this time.
- Those impacted by the storm will not be addressed in the near future
- We will likely be under last year's number of 62 member paid districts

B. September 2018 Statement from First Commerce Credit Union

- The account balance is \$ 102,289.02.
- There is a comfortable cushion, for now, in our CD investments.
- Interest earned through September 30th is \$705.95
- Interest rates are up and we are still hopeful we will able to donate \$1,000 to a worthy cause
- A one year certificate is maturing and we were able to get a 2.65% APY for a 2 year certificate
- Two more CDs will mature in November, which may benefit from rising interest rates

C. Action on FEN Certificate of Deposit #55 set to mature 11/7/18

- A \$1,000 CD is maturing if we do nothing it will remain the same at 2.25%
- There is an 18 Month 1.3% with no withdrawal penalty
- Dawn Baglos motioned to roll over for one year at 2.25, second by Kathy Scalise, all present voted in favor

IV. Discussion and/or Action on FADSS "GoFundME" for Hurricane Michael Impacted School Districts

- This account was created in response to Hurricane Michael to allow for charitable donations
- It is recommended that FEN provide a donation for \$1,000
